

#### **AGAINST** Marijuana Use: A Brain and Legal Buster

Students at Grand Terrace High School seem ignorant to the long term effects of various substances that individuals ingest. Narcotics are, and will always be, a large issue for the student populace. However, no drug can top the influence that marijuana has on the collective student body. Students are simply unaware of the dangers of using and abusing this drug.

The health risks of marijuana greatly outweigh its presumed benefits. Those without medical conditions who smoke it are taking great risks without a silver lining. Marijuana has 50- 70 percent more cancer causing substances than tobacco, according to medical professionals on the website, drugfreeworld.org. A small dose can cause as much lung damage as up to five consecutive cigarettes. It also affects the brain by diminishing mental capacity and memory, the website says.

Marijuana is also a federal crime in most cases. Norml.org states that for those in possession, the first offense for having any amount without a doctorapproved medical note will be issued a misdemeanor, fined up to \$1,000, and could serve up to a year in prison. Punishments only increase with offenses. Those who sell are committing a felony, can serve five years to life and pay up to a million-dollar fine.

Those without legal permission or a legitimate medical condition should greatly rethink their pastimes. The harm this drug could cause to the body and legal record should not be taken lightly. Being caught can ruin one's life in the blink of an eye and the long term effects could kill the body slowly. It is urged that everyone should make their choices wisely and for them to put their efforts into something more productive. **TE**

# **FOR** The History of Weed and Why it Should be Legalized

Marijuana legalization has been the hot talk for years. There are currently 23 states that have legalized medical cannabis and three states that allow it for medical and recreational use. Although marijuana is legal within the states, its still federally illegal.

So how did the federal government come to criminalize marijuana? The cannabis prohibition campaign began in the 1930's. What the prohibitionists did to campaign was remarkable. They exaggerated the effects of marijuana. Movies and advertisements ran in theaters and newspapers all around the world warned of the evils and dangers of its use. Most of the propaganda was filled with racism and fear. Every "fact" that they claimed to be scientifically proven ended up being completely false.

So, why did they take it this far? Many of the prohibitionists felt that cannabis stood in the way of their business and affairs. Hemp is the natural fiber product that is found within the stem of a marijuana plant can be used for many industrial purposes. History has shown that it has been used that way for over a thousand years. Hemp can be used to make clothes, paper, medicine, and even industrial oil.

Basically, the reason for their drive was greed, not for the sake of the people. So, in 1937, the Marijuana Tax Act was enacted making cannabis illegal, with the exception of industrial or medical purposes. When you look back at the legal history of cannabis, it is filled will lies, hatred, and greed, which is why we need to start changing our minds about cannabis. According to an article published on the Huffington Post, "legalizing pot could save the U.S. up to \$14 billion a year." The reason being that there are so many finite uses for cannabis. To add, some medical researchers say it helps treat some illnesses, including cancer, epilepsy, scoliosis, HIV/AIDS and insomnia (not an illness).

Something that may sound surprising is that the medical side of cannabis is finally being acknowledged and gaining support by both chambers of congress. The Compassionate Access, Research Expansion, and Respect States (CARERS) Act was filed just last March by representatives Steve Cohen and Don Young.

Some of the things that the act will accomplish, if passed, will allow states to legalize marijuana for medical use at the federal level, reschedule marijuana to a schedule II drug and eliminate barriers to medical marijuana research.

In an interview conducted by CNN, Dr. Sanjay Gupta asked Barack Obama about his views on the CARERS Act. He made the statement, "I'm on record as saying that not only do I think carefully prescribed medical use of marijuana may in fact be appropriate and we should follow the science as opposed to ideology of this issue but I'm also on record as saying that the more we treat some of these issues related to drug abuse from a public health model and not just from an incarceration model, the better off we're going to be." ## **Every 15 Minutes: A Survivor's Story**

Grand Terrace High School experienced a new first on April 16 by hosting a "Every 15 Minutes" program. The program, put on by the San Bernardino County Sheriff's Department, aims to teach high school students the dangers and consequences of drinking and driving through firsthand experience.

I was one of sixteen students who were selected to participate in the program. Little did I know, this would be an experience that would change my perspective and help me gain a new appreciation for my life and the people in it.

Standing in the back of my Advisory classroom after being "reaped," I listened to my obituary being read and examined my classmates' reactions, while trying to keep my composure and

a solemn expression on my face. It was difficult not to laugh, but I wanted to ensure that the event had the biggest effect possible.

After makeup was applied to my face in the library, I proceeded to the front of the school with the other students and watched the crash being prepared. During the crash scene, the nonchalant attitude I originally had about the incident faded. Although I knew the crash was simulated, watching my classmates being hoisted into ambulances, airlifted in a helicopter, arrested, and placed into body bags

caused the seriousness of the situation set in. This was something that could very easily occur to me or someone I love and it would all be due to one person's carelessness.

Then we were placed on an inmate bus and driven to the county jail, where we met up with the students who had been taken from the crash. We were given a presentation by a correction's officer as we ate lunch, toured the prison, in which we experienced the booking process for new inmates, including being locked in a holding cell. During this process, all I could imagine was how lonely and terrifying it would be to live in a cold place such as that, and that one mistake is all it takes to send you there for years.

Next, was the coroner's office, where freshly dead bodies are stored and examined. A coroner gave us a graphic presentation of cases he had worked on in the past, before taking us into the morgue. The smell of decomposing bodies was overwhelming. The coroner opened a door and revealed dozens of bodies in yellow bags that were neatly laid out on shelves. Looking at the bags was like seeing a ghost, since their identity, their story, was unknown. As I walked out, I flinched as my hand nearly brushed against one of the bodies.

Then was the county courthouse, where a prosecutor presented her closing argument to the case against the drunk driver in the simulated crash. She charged him with two counts of murder, one count of felony DUI, and two counts of causing great bodily harm to another person. She said he would be liable to pay for the damage to property, legal fees and death suits . The judge then proceeded into the courtroom and informed us that had this been a real criminal case, the driver would have likely been sentenced to 25 years to life for

his actions. Then we were taken to a hotel in Highland to spend the night. As we all ate dinner, we discussed the day's events and what we had learned from them.

We were introduced a police officer, who described to us his experience of losing his sister to DUI. As he told his story, he asked us to imagine the most important person in our life. I thought about my parents.

Then, he told us to imagine receiving a call from the police in the early morning hours, informing you that the person died in a DUI collision. Around this point, I began to feel all of the emotions that had built up throughout the day come to the surface, and I began to sob.

We were given letters written to us by our parents, which de-

scribed what they never had the opportunity to tell us before we died. As I read the letter from my dad, I felt a wave of guilt rush over me. I began to remember all of the mistakes I had made in my life, and I realized that, had I actually died, I would be leaving behind a bad legacy, with those mistakes permanently remaining unresolved. It reminded me how truly short life is and how there is no time to delay expressing how you feel and doing things that are important to you, that life must be lived with a sense of urgency.

The next morning, we awoke early to get to school before our mock funeral later that morning. The intensity of the experience, for me, was almost overwhelming. The emotions I had felt the day before were still fresh in my mind and the funeral caused new ones to surface. Each section of the funeral, from our solemn candlelit entrance, to the crash video, to the letter readings, to Josh Jahn's incredibly moving story, to delivering the roses to our parents, took every ounce of strength I had to make it through. Each event changed my perspective. It caused me to view my classmates in a different light, and I had a renewed sense of appreciation for the opportunity this program had given me to not only speak up, but prevent a tragedy in my life like the one Josh Jahn experienced.

After the funeral, we were finally reunited with our families. I opted to leave school early, but before I did, I took the opportunity to approach Josh Jahn, the speaker who lost his wife and two small children to a drunk driver, and tell him how his story had impacted me. After I got home, it took several days for me to bounce back from the emotions of everything I had witnessed and experienced.

Every 15 minutes someone dies as a result of an alcohol-related collision. Experiencing that tragedy for yourself is a grueling and traumatic experience, but I would do it all over again if I had the chance, because of the lasting lessons it ingrained into my mind and heart. Throughout this experience, I stayed strong, I persevered, I learned, and as a result, I survived. As long as you make smart decisions, use your better judgment, and refuse to drink and drive, so will you. **TE**







#### **Hacker Tools Increase Concerns**

CYBERSPACE- How aware are you of the security the hotels and temporary residences around the world actually offer? In 2012, the "Onity" lock used in major hotel chains around the world was hacked with a tool released at a hacker conference called "DefCon," allowing access even through a dead bolted hotel door.

This type of illegal entrance through digital and physical means is becoming common place. The extent of access that hacking tools can achieve is vast and endless.

There are even tools and toys on the market that can allow easy access to any WiFi networks that allow anyone to snoop around. They are easy to come by and easy to use. Some are more configurable than others, while some work right out of the box. Two such tools that I found were the WiFi Pineapple and the Kali NetHunter.

The WiFi Pineapple is a network auditing tool introduced by Hak5. Network auditing is the collection of data and analysis on the state of a network. The WiFi Pineapple is a user friendly way of seeing the status of every network in the area, It's a "man in the middle" attack device.

"The Pineapple can find a cell phone, computer, or any electronic that is connected to a target network and it can cut the connection with said network and reroute it to the attacker's own network, thus allowing the attacker to gain full control of the victim's traffic," explained Jeremy Martin, a Senior Cyber Warfare analyst. "This simple rouge attack makes the Internet of things (IOT) far more scary." TE

## Are Force Fields Here?

Boeing just laid claim to the patent for a method and system for shock wave attenuation via electromagnetic arc or in layman's, force fields.

Boeing has been granted a patent for a force field-like defense system. Filed in 2012, the USPTO has granted the aerospace giant a patent for a "Method and system for shock wave attenuation via electromagnetic arc." According to CNN.

On first look, it seems that they're onto something similar to "Star Wars" deflector shields but this is a bit different. The patent describes a system that would detect the shockwave from a nearby explosion and creates an area of ionized air – a plasma field – between the oncoming blast and the vehicle it was protecting.

The best part about all of this is that science proves this works, the patent says, "by heating a selected region of the first fluid medium rapidly to create a second, transient medium that intercepts the shockwave and attenuates its energy density before it reaches a protected asset."

However, at this stage of development, Boeing's force field would likely be powerless to protect against shrapnel or other debris flung out by an explosion, so the troops of the future would still need to keep their body armor firmly strapped on.

The plasma field would also be temporary—hence the need for sensors to activate it when a blast is detected, so the sort of all encompassing shields we're familiar with from the movies.

Researchers keep reaching into the bag of ideas that is science fiction, with new armor for troops, submarine killer drones, and working tractor beams among recent inventions that wouldn't look out of place in a galaxy far, far away. **TE** 

# EDITORIAL: Is Mars One Real or Hoax?

The Mars One mission has been a hot topic for debate recently with contestants for their program coming out and speaking of the incredibly shady process that Mars One has been using to "Select" their volunteers.

One such individual is Dr. Joseph Roche, an assistant professor at Trinity College's School of Education in Dublin, with a Ph.D. in physics and astrophysics. The former NASA Researcher didn't think much of it; he just wanted to throw his hat in the ring out of curiosity. However Dr. Roche soon found himself in the group's shortlist of top 100 contestants. He soon started having problems after this point.

It was difficult for him to break his silence, but he was spurred to do so by the uncritical news coverage. Many assumptions about the project remain unchallenged. Most egregiously, many media outlets continue to report that Mars One received applications from 200,000 when the number was 2,761. As Roche observed the process

his concerns increased. Chief among them: that some leading contenders for the mission had bought their way into that position, and are being encouraged to "donate" any appearance fees back to Mars One—which seemed to him very strange for an outfit that needs billions of dollars to complete its objective.

So, here are the rumors as we understand them: Mars One has almost no money. Mars One has no contracts with private aerospace suppliers who are building technology for future deep-space missions. Mars One has no TV production partner. Mars One has no publicly known investment partnerships with major brands. Mars One has no plans for a training facility where its candidates would prepare themselves. Mars One's candidates have been vetted by a single person, in a 10-minute Skype interview.

"My nightmare about it is that people continue to support it and give it money and attention, and it then gets to the point where it inevitably falls on its face," said Roche.

If, as a result, "people lose faith in NASA and possibly even in scientists, then that's the polar opposite of what I'm about. If I was somehow linked to something that could do damage to the public perception of science, that is my nightmare scenario," Roche said. **TE**


