Price of Bread One Cent Higher

Adjustment of price was made September 1, in an order signed last week by every first OPA Administrator Chester Boweach month les upon representation from eight major baking companies in the Los Angeles area that they could not continue making the one and a half pound loaf without a price increase. Local industry heads explained that a bread "price war" just prior to the freeze date on which OPA based its ceiling prices put local bakers at a disadvantage.

The order applies to Los Angeles, Kern, San Luis Obispo, Santa Barbara, Riverside, Imperial, Orange, San Bernardino and Ventura counties, and, wholesale bakers said, adjusts prices in this area to the national standard.

The order as signed permits a one cent a loaf increase at wholesale, to be passed on the retail level. Industry association heads in Los Angeles reported that their members are arranging to put the increased price into effect Monday.
